



SUPERBOOK WESTGATE LAS VEGAS HOOPS CENTRAL SHOWDOWN

MARCH 1, 2024 – MARCH 22, 2024

OFFICIAL CONTEST RULES

The “SuperBook Westgate Las Vegas Hoops Central Showdown” (hereinafter the “Contest”) refers to the events occurring between Friday, March 1, 2024 at 9:00 a.m. and Friday, March 22, 2024 (see rule 20) at 11:59 p.m., pending no games in delay. (“Contest Period”) at the Westgate Las Vegas Resort & Casino (“Sponsor”) located at 3000 Paradise Road, Las Vegas, Nevada 89109. All references to time of day contained herein refer to Las Vegas, Nevada Time.

1. All contestants must be at least 21 years of age to participate. Contestants must provide valid proof of age that is acceptable to the Westgate Las Vegas Resort & Casino (current driver's license, passport, or state identification card), which may act in its sole and absolute discretion as it deems appropriate. If contestant is not a U.S. resident, a current passport or alien registration card is required.
2. All contestants must have a Westgate Las Vegas Resort & Casino WOW Rewards card. Westgate Las Vegas Resort & Casino WOW Rewards cards are free and are available at the WOW Rewards Center, Casino Cage or the SuperBook.
3. Contestants can participate in the SuperBook Westgate Las Vegas Hoops Central Showdown by paying a one hundred dollars (\$100) entry fee. Entry fees are non-refundable and can only be paid in cash.
4. Entry fees will be accepted for the SuperBook Westgate Las Vegas Hoops Central Showdown starting at 9:00 a.m. on Friday, March 1, 2024, and conclude at 10:00 p.m. on Wednesday, March 20, 2024.
5. Maximum of five (5) entries per person. Each entry shall be treated as a separate entry for all purposes.
6. The SuperBook Westgate Las Vegas Hoops Central Showdown will begin Thursday, March 21, 2024, and conclude Friday, March 22, 2024 (see rule 20).
7. The SuperBook Westgate Las Vegas Hoops Central Showdown is based on selecting the game winner vs the contest point spread on twenty-eight (28) first round games in the 2024 Men's NCAA Men's Basketball Tournament played between Thursday, March 21, 2024, and Friday, March 22, 2024 (see rule 20). Contest lines will be set by the SuperBook Westgate Las Vegas. Contest lines will not move once they are set. Contestants must select one side for each of the 28 first round games available. In the event a contestant has multiple entries, they may select one side on one entry and the opposite side for another entry. Contestants cannot use opposite sides on the same entry.
8. Contest winners will be determined by the total number of points accumulated at the end of the first round of the 2024 Men's NCAA Basketball Tournament. Each winning selection will earn one (1) point. In the event a contestant has multiple entries, points do not combine.
9. Contestants will be required to swipe their Westgate Las Vegas Resort & Casino WOW Rewards card at the SuperBook Westgate Las Vegas self-service contest window to make their selections. By signing the official entry form, the entrant becomes the “official contestant” and is the only one approved to collect prize money.
10. Contestants must submit their selections over the counter at the SuperBook Westgate Las Vegas between Monday, March 18, 2024, at 4:00 p.m. and Wednesday, March 20, 2024, by 10:00 p.m. This deadline will be strictly enforced. Contestants who fail to submit their selections will be awarded zero (0) points for each team.
11. The selection ticket (receipt) generated by the SuperBook Westgate Las Vegas computer system is the official entry of record. The contestant's official selections will be those contained in the SuperBook Westgate Las Vegas computer system records. If a selection ticket is not produced via the self-service contest window, the contestant must notify a SuperBook Westgate Las Vegas supervisor immediately to receive a printed copy of their selections. The “selection sheet” itself is not an official entry of record.
12. Selections are only submitted once per contest entry. Contestants cannot void selections after the SuperBook Westgate Las Vegas business day they are submitted. All SuperBook Westgate Las Vegas Hoops Central Showdown selection ticket void requests must be submitted to a SuperBook Westgate Las Vegas Supervisor for approval. In the event a contestant has multiple entries, a contestant must submit separate selections for each entry. If more than one (1) selection is erroneously accepted for an entry, the first selection associated with the entry will be the official selection of record.
13. All contest entry fees will be paid to contest winners under the following winner's schedule:
 - 1st Place 50% of prize pool
 - 2nd Place 30% of prize pool
 - 3rd Place 20% of prize pool
14. 14. TIEBREAKER: All contestants will enter the combined score of both teams in a designated game chosen by SuperBook Management. i.e. if you think the combined score of both teams will be 150, select 150. In the event of any ties for all places (1st – 3rd), the contestant who is closest to the actual combined score will be declared the winner. In the event a tie still exists, all prize money will be divided equally between all the contestants who remain tied.

15. All games must complete thirty-five (35) minutes of game time. In the event a game does not complete 35 full minutes of game time, both sides will receive zero (0) points for the purposes of the SuperBook Westgate Las Vegas Hoops Central Showdown.
16. All SuperBook Westgate Las Vegas house rules apply to this contest unless otherwise stipulated by the rules.
17. The SuperBook Westgate Las Vegas reserves the right to cancel this contest or refuse to accept any registration or wager if the same could violate any federal, state, or country law, ordinance, or regulation. Furthermore, the SuperBook Westgate Las Vegas may cancel the contest in the event of technical difficulties or other occurrences beyond the control of the SuperBook Westgate Las Vegas.
18. Selections may be accepted manually in case of a computer system failure or other unforeseen circumstances as deemed necessary by the SuperBook Westgate Las Vegas management.
19. Entry fees will not be refunded for any reasons other than the cancellation of the SuperBook Westgate Las Vegas Hoops Central Showdown.
20. NCAA.com and ESPN.com will be the official source used to post results. Games must be played by the end of day on Sunday, March 24, 2024. In the event a scheduled contest game is not played by the end of the day Sunday, March 24, 2024, it will be eliminated from the contest and will not count for contest purposes.
21. After the winners are identified, a one (1) day verification period will occur. Any disputes with the contest and/or results must be provided to management in writing within this verification period. At the end of the one (1) day verification period, the SuperBook Westgate Las Vegas Hoops Central Showdown results will be declared official. In the event of a dispute, the decision of management is final.
22. Management reserves all rights.
23. Prizes are non-transferable. All federal, state and local taxes and expenses related to the acceptance and use of the prizes are the sole responsibility of the winners. Prizes may be subject to reporting and withholding pursuant to federal IRS regulations, and participants are required to cooperate with Westgate Las Vegas Resort & Casino in completing necessary forms.
24. Employees, as well as family and household members of Westgate Las Vegas Resort & Casino, may not participate in the SuperBook Westgate Las Vegas Hoops Central Showdown.
25. By participating in this Contest, participants agree to comply with all rules contained herein.
26. All entries are subject to review and verification.

29. All references to time of day contained in these rules refer to Las Vegas, Nevada time.
30. All contest times are approximate.

Westgate Las Vegas Resort & Casino reserves the right to modify or cancel this contest at any time for any reason, subject to any applicable regulatory approval provided that such modification shall not, as the date of such modification, materially alter or change any participant's prize already awarded.
